COURSE #1 Time: 1:00—6:00 p.m.

Title: Evaluation and management of neuromusculoskeletal conditions of the extremities

This lecture and lab course emphasizes the use of evidence-based, orthopedic and neurological evaluation procedures and patient-centered, conservative treatment procedures. The introduction of an organized clinical thought process prepares attendees to perform evaluations of patients with neuromusculoskeletal conditions of the extremities. Teaching of the SOAP process enables attendees to organize their exam process, expedite recording of subjective and objective findings, assessments and plans.

Title: Nutrition and wellness for the chiropractor

Emphasis will be on musculoskeletal conditions but will include a broad approach to overall health and wellness and certain prevalent conditions in the American population.

Title: Electronic resources that support your diagnosis

Interpretation involves the understanding of certain statistics in clinical and epidemiology, which will be taught. After completion the doctor should know the importance and utility of evidence in clinical practice and understand the meaning and use of the statistics used in clinical epidemiology.
